## **BRASCNA Treasurer Report May 2025**

Please excuse my absence from Area this month. I had shoulder surgery this week and am unable to attend in person. But, I have submitted my report for review. If Nancy or Bob could collect the donations for me, I would appreciate it. If there is a way for me to Venmo or PayPal the church I can send the rent for May. Otherwise, I will have to pay 2 months rent at next Area in June. As of May 24, 2025, we have a cash bank balance of \$4,418.50.

I have attached the treasurer's spreadsheet showing all revenue and expenses from January 2025 to date with the beginning and ending balances matching the bank transaction report. On this month's report I added a "remaining budget" column per Area's request last month.

The Treasurer's report shows the cumulative income and expenses received and/or paid by Area from January to December each year, with annual year to date totals at the end along with remaining budget balance. I also include the bank statement, bank transaction report, and monthly group donations report.

### Important notes:

1. There is a \$1,700.00 check for literature expenses not represented in this report from the Lone Star Area which will be shown in next month's treasurer's report. It is comprised of group literature along with H&I and PR and was delivered to the convention.
2. I had to file the annual secretary of state annual report for our Area. Pixie is listed as Agent of Record, me as Treasurer, and Bob Singer as Officer. Because Bob's address is listed as the bank account address, I can't remove him from the filing. We can make whatever changes necessary once we have elections for the new year and new people are added and removed from the Secretary of State reports based on positions.

Last month we discussed emptying the storage shed and not continuing the contract for the next renewal. Has this been done? I need to request a refund once we remove all our stuff.
